REMOTE LEARNING FOR THE 2020-2021 SCHOOL YEAR
SCHOOL DISTRICT/PARENT COMPACT**

Due to the March 2021 recent updates in the ISBE and IDPH Joint Transition Guidance and recommendations from the CDC and IDPH, students are only being offered remote learning for fourth quarter in the following circumstances: (1) the student is at an increased risk of severe illness (including students with special health care needs), or (2) the student resides in the same household with an individual who is at an increased risk of severe illness. If your student does not fall under these circumstances, then your student will return to in-person instruction as of March 15, 2021. If one of the above circumstances apply to your student, please provide medical documentation to the school office by Friday, March 19, 2021. If you have already supplied the school with medical documentation earlier in the school year, please contact the school office to let us know your child will remain on remote and sign the School District/Parent Compact and return no later than March 19, 2021.

As the parent/guardian of _____, I confirm that my student falls under one of the above circumstances and I am therefore making the choice to enroll him/her in the remote learning program for the fourth quarter of the 2020-2021 school year.

I agree to abide by the following guidelines of the program:

1. I understand that the remote learning program will officially begin on March 15, 2021.
2. My child will be enrolled in the remote learning program on a quarter-by-quarter basis.
3. My child will be responsible for providing proof of attendance each day by using a teacher-approved mechanism (*See-Saw, Google Classroom, Zoom, Teacherease, etc.*). Note: K-5 attendance is recorded once in the morning. 6th-12th grades are recorded in the morning via Teacherease (7am-8:15am) and each class period by the teacher.
4. My child will be responsible for participating in live class sessions and/or viewing recorded sessions that are made available by the teacher using an online platform. *Under special circumstances, the teacher, parent, and student will work together to determine other learning platforms to meet the learning needs as determined by my child's IEP or 504.*
5. My child will be responsible for all assigned homework and the submission of work will be made in the timeline as assigned by the teacher.
6. Based on state guidance, my child will be responsible for participating in approximately 2.5 hours of teacher-student instruction and a total daily education time of approximately 5 hours.
7. My child understands that **all handbook rules apply while participating in remote learning.**
8. I, as the parent/guardian, understand that all school policy and procedures will apply while my child is participating in remote learning. **The student should be in a quiet location to eliminate distractions**

and avoid having siblings, friends, pets etc. in the room with him/her. Students are not to be driving, riding in cars, shopping or participating in any other activity other than participating in class. Video should be on at all times with the student in view for the teacher to see. Students are to be dressed appropriately and follow school dress code. No hats, cell phone use, eating etc. should take place during class.

9. I, as the parent/guardian, will make adequate technology available for my child at home in order to meet the requirements of the remote learning program.

10. I understand that accountability will be expected from my child. Attendance will be recorded, homework will be assigned, grades will be taken, and the program will run as if my child was at school.

Note. Disciplinary action may be taken if these guidelines are not followed.

11. I understand that if my child opts to participate in remote learning in place of in-person learning, they will not be allowed to participate in extra-curricular activities affiliated with the school such as sports, camps, after school and summer programs until the beginning of the 2021-2022 school year.
